



EIGHTH EXTENSION

PUBLIC CALL FOR THE ELECTION OF THE REPRESENTATIVE OF NONPROFIT ENTITIES – ESAL BEFORE THE BOARD OF DIRECTORS OF THE CORPORATION FOR THE SUSTAINABLE DEVELOPMENT OF THE ARCHIPELAGO OF SAN ANDRÉS, PROVIDENCE, AND SAINT KETHLEENA – CORALINA

The Ad-Hoc General Director of the Corporation for the Sustainable Development of the Archipelago of San Andres, Providence and Saint Kethleena – CORALINA –, in exercise of his legal and statutory powers, especially those conferred by Agreement No. 001 of February 25, 2022, issued by the Corporate Assembly of the Corporation, by means of which the Bylaws of the Corporation for the Sustainable Development of the Archipelago of San Andrés, Providencia and Santa Catalina – CORALINA – were adopted, as well as the provisions of Resolution No. 0862 of August 31, 2023, issued by the Ministry of Environment and Sustainable Development, and the Public Call for the Election of the Representative of Non-Profit Entities – ESAL before the Directive Board of the Corporation for the Sustainable Development of the Archipelago of San Andres, Providence and Saint Kethleena – CORALINA, hereby **EXTENDS FOR THE EIGHTH TIME** the Public Call, so that Non-Profit Entities – ESAL may take part in the process for the election of the representative of non-profit entities – ESAL before the Directive Board, based on the provisions set forth in Section IX of the CALL FOR THE ELECTION OF THE REPRESENTATIVE OF NON-PROFIT ENTITIES – ESAL BEFORE THE DIRECTIVE BOARD OF THE CORPORATION FOR THE SUSTAINABLE DEVELOPMENT OF THE ARCHIPELAGO OF SAN ANDRES, PROVIDENCE AND SAINT KETHLEENA – CORALINA, which was issued on August twentieth (20), 2025, and duly published through the various dissemination media, in compliance with the principles of maximum disclosure, transparency, and access to public information set forth in Articles 2 and 3 of Law 1712 of 2014.

Pursuant to the foregoing, Section IX of the **CALL FOR THE ELECTION OF THE REPRESENTATIVE OF NON-PROFIT ENTITIES – ESAL BEFORE THE DIRECTIVE BOARD OF THE CORPORATION FOR THE SUSTAINABLE DEVELOPMENT OF THE ARCHIPELAGO OF SAN ANDRES, PROVIDENCE AND SAINT KETHLEENA – CORALINA**, provides as follows:

XI. EXTENSION OF THE CALL WITHIN THE PROCEDURE FOR THE ELECTION OF THE ESAL REPRESENTATIVE BEFORE THE DIRECTIVE BOARD:

Once the deadline established for compliance with the requirements referred to in Articles 6 and 7 of Resolution No. 0862 of August 31, 2023, issued by the Ministry of Environment and Sustainable Development, has expired, and if no ESAL within CORALINA's jurisdiction has submitted such documentation or if at least four (4) qualified candidates have not been nominated, the General Director of CORALINA shall record this circumstance in minutes and shall extend the call through a notice, under the terms provided in Article 5 of Resolution No. 0862 of August 31, 2023, issued by the Ministry of Environment and Sustainable Development, which shall be published within fifteen (15) calendar days following the expiration of the deadline established for the reception of the referenced documentation and the nomination of candidates.

Whenever, in accordance with the provisions of this article, it has been necessary to extend the call, the deadlines established for holding the election meeting shall be adjusted, taking into account all cases, such that the election meeting must be held within thirty (30) business days following the notice of extension of the call.

When the extension of the call takes place in order to complete the minimum of four (4) qualified candidates, those who have submitted documentation to evidence compliance with the requirements based on the initial call shall not be required to submit such documentation again.

The foregoing shall be reported to the Office of the Attorney General of the Nation.

Consequently, the Closing Minutes and Record of Registered Applicants signed by the Ad-Hoc General Director and the Acting General Secretary of CORALINA, dated **April 8, 2026**, recorded that no registrations were received either to apply as candidates or to nominate candidates, which would allow reaching the minimum number of qualified applicants, under the terms of the Public Call and
