"By means of which a SHORTLIST of three candidates is selected for the Election of the Director of the Office of Control of Circulation and Residence OCCRE of the Departmental Archipelago of San Andres, Providence, and Santa Catalina Islands.

THE GOVERNOR (In Charge) OF THE DEPARTMENTAL ARCHIPELAGO OF SAN ANDRES, PROVIDENCE, AND SANTA CATALINA ISLANDS, in exercise of his Constitutional, Legal and Regulatory Powers, particularly those conferred by Article 305.2 of the Constitution, Article 24 of Decree Law 2762 of 1991, Article 5.b of the Internal Regulations of the Occre- approved by Agreement 001 of 2019,

CONSIDERING

According to Article 24 of Decree 2762 of 1991, "The Director of the Office shall be appointed for a term of one year by the Board of Directors from a list of three candidates presented by the Governor of the Departmental Archipelago and may be re-elected."

That since the term of the current Director of the Office of Circulation Control and Residence - OCCRE ends on February 18, 2025, the call was opened to select the shortlist of candidates for the position of Director of said office, providing that any interested professional, with a defined residence in the Islands, could submit his/her resume for consideration of analysis for compliance with the requirements within the period between January 20th and 31st of this year by Decree 0017 of January 13, 2025.

That the closing of the Call took place on January 31, 2025, at 6:00 p.m. verifying the timely registration of nine (09) resumes:

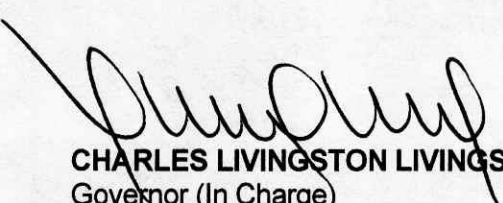
SECOND ARTICLE: Through the Secretariat, notify the nominees of the decision.
