"By which an appointment is made".

THE GOVERNOR OF THE ARCHIPELAGO DEPARTMENT OF SAN ANDRES, PROVIDENCIA AND SANTA CATALINA, in the exercise of his constitutional and legal powers, especially those conferred in Law 909 of 2004 and Decree 1083 of 2015, and

CONSIDERING

That the second paragraph of Article 23 of Law 909 of 2004, in concordance with the first paragraph of Article 2.2.5.3.1 of Decree 1083 of 2015, establishes that the definitive vacancies of freely appointed and removable positions shall be filled through ordinary appointment or through assignment, subject to meeting the requirements demanded for the performance of the position and the procedure established by law.

titled SECRETARY OF OFFICE, with classification code 020 grade 20 under the SECRETARIAT OF HEALTH.

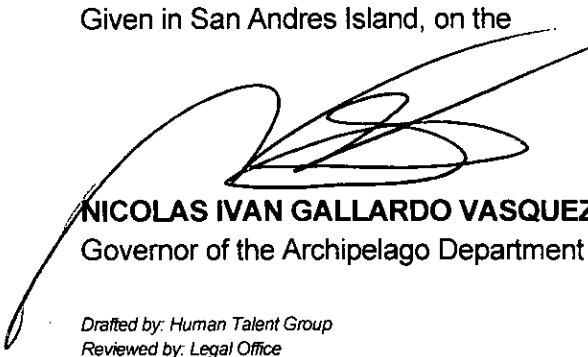
ARTICLE TWO: Communicate the content of this decree to Mr./Ms. YENDI SHANDIRA KELLY FORBES.
