ORDINANCE No. 006 OF 2025
(April 15, 2025)

"BY WHICH THE GOVERNOR OF THE ARCHIPELAGO DEPARTMENT OF SAN ANDRES, PROVIDENCIA AND SANTA CATALINA IS AUTHORIZED TO TRANSFER, FREE OF CHARGE, SOME REAL ESTATE PROPERTIES OWNED BY THE GOVERNMENT"

THE ASSEMBLY OF THE ARCHIPELAGO OF SAN ANDRES, PROVIDENCIA AND SANTA CATALINA, in exercise of its Constitutional and legal faculties, especially those conferred by numeral 9 of Article 300 of the Political Constitution, Article 19 of Law 2200 of 2022, and particularly those provided in Articles 10, 11, 12 and 13 of Law 47 of 1993.

ORDERS

ARTICLE ONE. Authorize the Governor of the Archipelago Department of San Andres, Providencia and Santa Catalina, in accordance with current regulations, to transfer free of charge to the NATION – SUPERIOR COUNCIL OF JUDICATURE – EXECUTIVE MANAGEMENT OF JUDICIAL ADMINISTRATION, the Government-owned properties identified with the property registry numbers 450-4650 and 450-4651, with cadastral code 880010100000000250035000000000 and previous cadastral code 01-0025-0034-000, respectively, located in the ROCK HOLE sector.

ARTICLE TWO. The properties transferred free of charge under this Ordinance shall be destined for the construction of the Palace of Justice of San Andres Island.

ARTICLE THREE. The Governor of the Archipelago Department of San Andres, Providencia and Santa Catalina may execute any act required for the transfer.

ARTICLE FOUR. The Governor of the Archipelago Department of San Andres, Providencia and Santa Catalina shall have six (6) months to carry out the necessary procedures and steps to transfer free of charge the properties identified with registry numbers 450-4650 and 450-4651.

ARTICLE FIVE. The properties subject to be transferred under this Ordinance shall have a term of five (5) years from their delivery to be used for the authorized purpose. If they are destined for a different use, they must be returned to the Administration of the Archipelago, without prior request. Likewise, their transfer by the NATION.

ARTICLE SIX. This Ordinance shall take effect as of the date of its publication and repeals all others provisions to the contrary.
